<p>1. Membership</p> <p>1.1. Eu Rewards membership is applicable to any person aged 18 years and above.</p> <p>1.2. A name change on the member's record will be accepted upon written notification to Eu Yan Sang (Singapore) Pte Ltd ("EYSS") using the Correction Request Form available at retail outlets.</p> <p>1.3. Members can cancel their Eu Rewards membership at any time by submitting the appropriate written notification and returning the membership card to EYSS, at which time any outstanding benefits, privileges and Eu Rewards points will be cancelled.</p> <p>1.4. Membership is not transferable and membership card is non-refundable. There will be a S\$5 replacement fee for lost card.</p> <p>1.5. EYSS reserves the right to reject any application for membership.</p> <p>1.6. The privileges and/or terms and conditions may be amended or withdrawn without prior notice at the discretion of Eu Yan Sang Group of Companies.</p> <p>1.7. Points earned are based on the total nett amount settled in each transaction. A minimum of S\$5 purchase is required before any points are issued.</p> <p>2.2 Points can be redeemed for use in purchases at Eu Yan Sang Singapore retail outlets. To be eligible for point redemption, Eu Rewards member card must be presented and to provide last 4 digits & alphabet of NRIC/other National Identification numbers <u>or</u> mobile number for verification at cashier before payment. In the absence of the member card, member has to provide last 4 digits & alphabet of NRIC/other National Identification numbers <u>and</u> mobile number for us to retrieve your membership account.</p> <p>a. Points jointly accumulated from more than one Eu Rewards card are not accepted to be redeemed for one purchase</p> <p>b.
