The Board of Directors of Eu Yan Sang International Ltd wishes to announce the issue and allotment of:

- (i) an aggregate of 48,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.668 each, pursuant to the exercise of options granted under the Eu Yan Sang Employee Share Option Scheme 2006 (“ESOS 2006”);
- (ii) an aggregate of 54,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.481 each, pursuant to the exercise of options granted under ESOS 2006; and
- (iii) an aggregate of 54,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.569 each, pursuant to the exercise of options granted under ESOS 2006.
